### 2023 FAIR HOUSING CONFERENCE

FHANC's 2023 conference, "Fair Housing: A Closer Look - Building Inclusive Communities through Policy and Advocacy," was held virtually on Friday April 21, 2023, with 7 speakers and over 200 attendees. The sessions addressed strategies for advancing fair housing and racial equity through policy and advocacy, with sessions on reparations, appraisal discrimination & inequality, source of income discrimination, and Affirmatively Furthering Fair Housing (AFFH) implementation. The event brought together community members, non-profits, advocates, real estate professionals, municipal leaders, and staff.

# Foreclosure Prevention

FHANC's mortgage fitness department is dedicated to keeping homeowners in their homes. Our number one priority is stabilizing the primary mortgage and forestalling foreclosure. This can take many forms - forbearance, loan modification, accessing the California Mortgage Relief program, and more. We look at what type of loan the household has, if their hardship has ended, and if they can afford their payment. Each case is different, and we look forward to speaking with you and evaluating your best options!



#### Foreclosure Prevention cont.

Clients have been hampered by issues such as inheriting a home from a loved one and grappling endlessly with a lender that refuses to complete their successor-in-interest paperwork, thereby blocking all pathways out of foreclosure. This was the case for one homeowner, a single mother of two small children. We helped her through the successor process and the mortgage relief program. She expressed her gratitude and relief through a note to her counselor: "... I am so very grateful you took my file; your tenacity and wisdom are unmatched." Another single father of two in a similar situation stated, "Thank you. From the bottom of my heart, I am so utterly relieved...you know you are a blessing and an angel in this world, and I just thank you so much."

for outstanding contributions in fair housing.
Arusha is remembered for founding a fair
housing and anti-predatory lending law firm,
leading groundbreaking litigation in
protecting tenants with disabilities, home
child care providers, and many others.

Following a historic settlement with Fannie Mae focused on rebuilding communities of color, FHANC has expanded fair housing services in Solano County!
