

## 1. AB 686 (Santiago)



- Enshrines obligation to
   Affirmatively Further Fair
   Housing in CA law.
- Applies directly to activities related to housing and community development undertaken by all local, regional, and state governments.

#### Embracing a Balanced Approach

"Affirmatively furthering fair housing" means taking meaningful actions, in addition to combating discrimination, that overcome patterns of segregation, address disparities in housing needs and in access to opportunity, promote fair housing choice, and foster inclusive communities free from barriers that restrict access to opportunity based on characteristics protected by this part; and that transform racially and ethnically concentrated areas of poverty into areas of opportunity, while protecting existing residents from displacement.

- General Plan Housing Elements
- Regional Sustainable Communities Strategies

#### Must

- Analyze Barriers that Restrict Access to Opportunity
- Commit to Meaningful Actions that AFFH

#### 2. CA's Housing Element System

- □ Fair Share for All Cities & Counties
- Regional Housing Needs Allocation (RHNA)
- Local Housing Elements
  - Sites with appropriate zoning
    - Density
    - Availability
    - Development Standards
  - Policies to address public and private barriers to affordable development
- Enforcement

#### Challenges & Solutions

- □ Infeasible Sites: AB 1397
  - Too Small (or Too Big)
  - Existing Uses
  - Environmental Constraints
- □ Good Sites ≠ <u>Affordable</u> Housing: SB 166
  - Affordable housing "opportunity sites" develop as something other than affordable housing
- Inadequate Enforcement and
   Performance Incentives: AB 72

#### 3. Environment + Equity (Dis)Connection

Maximizing social equity also maximizes environmental benefits, reduces sprawl, and creates healthier regions.

# Jobs-Housing "Fit" Affordable Homes near Low-Wage Jobs





Figure 4. Jobs-housing fit for census tracts in the San Francisco Bay Area. Ratios calculated at 2.5-mile buffers around census tracts. Sources: 2011 LEHD Origin-Destination Employment Statistics dataset (job locations), 2007–2011 American Community Survey five-year estimates (rental unit locations and price).
